Dear Shareholder of CION Investment Corporation (the “Company”):

The Company’s board of directors declared and the Company paid a base distribution with one record date for the month ended March 31, 2026. Declared base distributions are paid monthly. The Company determined that the distribution was derived from the following sources on a tax basis:

Each shareholder will receive a Form 1099-DIV following the end of the 2026 calendar year, which will reflect the actual amounts of income, capital gain and return of capital paid by the Company, if any. The final determination of the tax attributes of our distributions is made annually as of the end of the Company’s fiscal year. Such amounts will be taxable in calendar year 2026 and reportable on your 2026 federal and other income tax returns.
