Dear Shareholder of CION Investment Corporation (the “Company”):

The Company’s board of directors declared distributions for one record date during the three months ended March 31, 2022. Declared regular distributions are paid quarterly. The Company determined that the distributions were derived from the following sources on a tax basis:

Each shareholder will receive a Form 1099-DIV following the end of the 2022 calendar year, which will reflect the actual amounts of income, capital gain and return of capital paid by the Company, if any. The final determination of the tax attributes of our distributions is made annually as of the end of the Company’s fiscal year. Such amounts will be taxable in calendar year 2022 and reportable on your 2022 federal and other income tax returns.
